ORDER

The prayer for allotment of symbol for exclusive use by the candidates nominated by "Jharkhand Mukti Morcha", Central Committee in each tier of Panchayats in all the districts of the State except Darjeeling district has been examined and it is found that the Election Commission of India allowed the said party to contest for Assembly elections in West Bengal during the last General Elections to the Loksabha held in 2009 and Assembly Election in 2011 with the reserved symbol "Bow & Arrow".

Now, therefore, in exercise of the power conferred by sub-clause (ii) of Clause (C) of sub-rule (2) of Rule 32 of the West Bengal Panchayat Election Rules, 2006, the State Election Commissioner, West Bengal State Election Commission has been pleased to allow the Jharkhand Mukti Morcha to contest elections from the different Constituencies of Gram Panchayat, Panchayat Samiti and Zilla Parishad in West Bengal with the symbol of "Bow & Arrow" as reserved symbol in the ensuing Panchayat General Elections, 2013.

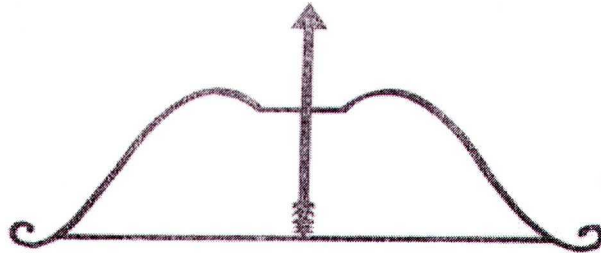
