Madam/Sir,

I am directed to invite your attention to Rule 49 of the West Bengal Panchayat Elections Rules, 2006, framed under the West Bengal Panchayat Elections Act, 2003, specifying persons eligible for entering Polling Stations.

In this connection, it may be mentioned that during past Panchayat elections some unauthorised persons have tried to enter the polling stations on one pretext or another with some ulterior motives leading to disruptions in the poll process.

I am, therefore, directed to request you to advise the Presiding Officers, Sector Officers and others concerned for conduct of the poll to be vigilant in this regard and to ensure that no unauthorised person enters the polling stations in violation of the above statutory provision.
