Tax and commercial vehicle tax clearance certificate in their envelop. The sealed quotation should be submitted to the Land Acquisition Officer, Malda Collectorate, Malda on & from 21/01/2019 to 22/01/2019 at normal office hours and on 24.01.2019 within 02:00 pm and the same will be opened on 24.01.2019 at 3:00 pm as per following conditions:

1. Monthly hire charges should be offered excluding fuel. The rate is to be quoted both in words and figures. No other charges apart from the hiring charges will be given to the successful tenderer.
2. The vehicle is to be provided for 24 hours on monthly basis (including Saturday, Sunday & Holiday).
3. Maintenance of the vehicle, payment of all taxes etc. should be made by the owner of the vehicle.
4. Repair works on any should be done with prior approval of the undersigned. If the repair works continues for more than one day, same type of vehicle is to be replaced by the owner. Expenditure for any repair of the vehicle is to be borne by the owner.
5. One printed log-book provided by the office should be maintained by the driver with authentication of the undersigned.
6. Registration of vehicles preferable should be within 01 (one) year from the current date and preference will be given to BS-IV model & to the vehicle of latest registration depending on the rate of hiring charge.
7. Fuel will be borne by the office of the undersigned fuel will be issued @ 10 kms. per litre.
8. Mobile will be borne by the office of the undersigned mobile will be issued @ 500 kms. per litre
