Intending Tenderers must apply in writing together with documentary evidences in support to their experiences & competency regarding execution of such type of jobs. Tenderers should have sound knowledge over such type of jobs and has to submit successful credential(s) at least 40% of work value in a Single Tender of similar type of job within last 2 (Two) years. This is to be shown at the time of permission. Valid sales tax, Income Tax , P. Tax payment certificate , VAT with Clearance Certificate and Goods and Services Tax (GST) Registration Certificate. (The 15 digit GSTIN Registration number under GST act, 2017 should be mentioned). , PAN & Trade license, Service Tax (if applicable) Registration Certificate must be produced at the time of issuance of those Tender Documents from the Deputy Director of Agriculture(Admn), Malda.

Necessary deduction on GST (Goods and Service Tax), Income Tax, etc will be made as per the prevailing Government norms.


The tenderer must have Valid Electrical Contractors License, with Electrical Supervisor holding Supervisor competency on the parts 1, 2, 3, 4, 5, 6(A), 6(B), 7(A), 7(B), 10, 11 & 12 as per I.E. rules.

Rates should be quoted in figures as well as in words percentage basis Above / Below / AT PAR with the rates shown in the Schedule above mentioned work. No. S.T. will be paid extra. No. tender with price variation clause will be entertained.

In case of rates of the lowest Tender be found excessive such rates may be reduced on the basis of actual analysis before acceptance of the tender. Acceptance of lowest is not obligatory and the accepting authority reserves the right to reject any or all of the tenders without assigning any reason thereto.

The Earnest Money of all the tenderers other than lowest tenderer shall be refunded within the stipulated period as per Government rule. The test certificate of the completed Electrical Installation is to be submitted by the working contractor along with the claim for Final Bill

Last date of Application is on 12.11.2018 up to 2.00 pm. Last date of Issue of tender papers is on 14.11.2018 up to 5.00 pm & tenders will be received on 15.11.2018 up to 3.00 pm & the same will be opened on 15.11.2018 at 3.30 pm in presence of tenderer who may wish to be present during opening.


