

The Schemes of KVIB, WB(Khadi & Village Industries Board) implementing through its District Office of Malda at 77A/95, K.J. Sanyal Road, Atul Ch. Market (CCPC Building), PO & Dist-Malda.

There is a District Office of KVIB, WB in Malda town at CCPC Building at Atul Market. This office is implementing the schemes of KVIC (Khadi & Village Industries Commission), Govt of India & various schemes of the Dept of MSSET, Govt of WB in Khadi & village industries sector.

Main objectives of this office are:-

- Generating employment through various individual & institutional ventures.
- Encouraging unemployed people to become self-employed by setting up of various micro level industry units.
- Encouraging Khadi artisans / institutions to produce & procure Khadi products.
- Development of Economic status of Boarder areas of the district by hiking per capita income through financial & infrastructural assistance to industry ventures.
- Development of clusters where a number of people are engaged in some group activities.
- Creating Mass Awareness for self-employment (Entrepreneurs' Development Programme).
- Conducting Skill Development Training for developing some specific craftsmanship.

Cluster Development Approach taken by the District Office of WBKVIB

- The District Officer, Malda, WBKVIB has initiated a project proposal of cluster development with Anandamayee Mahila Sangha at Arapur, Kotwali, English Bazar.
- There are 70 Self Help Groups (consisting of about 700 women members) in the Sangha working under District Rural Development Cell of Malda.
- Those families are producing handmade products from Mango like Mango-Bar (Aamsatta), pickles, Aamchur, products from pulses (bori), products from potato etc.
- The project proposal of the District Officer, KVIB includes machineries & infrastructural supports to the members of the Sangha for producing jam, jelly, pickles, Mango-Bar, Squash, tomato sauce, products from pulses, potato chips etc.

- Department of MSSET, Govt of WB has sanctioned an amount of Rs.52.44 lacs in favour of this project in the month of April, 2012 & the implementation work has already been initiated by the District Officer, Malda.
- About 700 families will get benefit out of this project & the per capita income of the entire area will be raised.
- The District Magistrate, Malda has sanctioned an amount of Rs.30 lacs for this project out of the Infrastructure Fund of DRD Cell of Malda.
- It is expected that this cluster will be able to commence production within September, 2012.
